1. Sinja Rural Municipality, Office of Rural Municipal Executive, Narakot-03, Jumla, Karnali province, Nepal towards the cost of Hima Nadi Ranukhana ra Kotesanghu Narakot Bailey Bridge Construction Works Sinja Ward No. 02, 03, Jumla and intends to apply part of the funds to cover eligible payments under the Contract for SRM/NCB/WORKS/01/2082/83. Bidding is open to all eligible as per Section V of bidding document.
2. Sinja Rural Municipality, Office of Rural Municipal Executive, Narakot-03, Jumla invites sealed bids or electronic bids from eligible bidders for the construction of Hima Nadi Ranukhana ra Kotesanghu Narakot Bailey Bridge Construction Works Sinja Ward No. 02, 03, Jumla under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 6,03,55,000
 - Minimum Work experience of similar size and nature: Fabrication, Supply, Transportation, Construction and Erection of 2 Nos Bailey Bridges of Span above 25 m with in last five years, with a value of at least NRs 4,83,00000 (incl. VAT).
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- Or
- Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
4. Bidder shall submit a letter of authorization from Manufacturer Company and schedule of requirement as specified in work requirement. It is mandatory to submit with bid as additional technical document

Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below .

7. Electronic bids must be submitted to the office Sinja Rural Municipality-3, Narakot, Jumla by PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2082.08.16 (2nd Dec. 2025]. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 2082/08/16 (2nd Dec. 2025) at the office of Sinja Rural Municipality-3, Narakot, Jumla.. Bids must be valid for a period of 120 from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 1510000. (2 to 3 % of estimated amount without VAT and Contingencies but including PS)], which shall be valid for 30 days beyond the validity period of the bid
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
